- A) The football team played into December this year. They finished the year with a 12-1 record as NCAC champs. The only loss came in Minnesota against St. Thomas quarter-final round of the D-3 playoffs. Senior Mason Zurek was named D3football.com North Region Offensive Player of the Year and head coach Erik Raeburn received Regional Coach-of-the-Year honors. - 5. Time for a pitch from Dean of Admissions, Mike Thorp '86:
 - "Never shy away from a conversation about costs. [Besides the fact that everything is more expensive than in the 1980's, Wabash has improved since then. It also has a better <u>4</u>-year graduation rate then many other colleges which helps keep down the true cost of a degree.] Our 4-year graduation rate is 70-74%. For comparison, the rate at Purdue is 37% and at I.U. it's 49%. It would take a student 6 years of tuition/room/board at those schools to come close to our 4-year rate. After our average scholarship, it's less expensive to graduate from Wabash."
