

# **ANNUAL FUND INFORMATION FOR FACULTY AND STAFF**

## **Payroll Deduction**

You can make your annual contribution to Wabash through payroll deduction. Fill out the payroll deduction form and return it to the Office of Annual Giving in the Hays Alumni Center. Please indicate how much you want taken out of your check with the exact amount per pay period and how long you would like that amount to be taken out. For example, a \$20.84 gift deducted from your paycheck for 12 months is a generous \$250.00 gift to the College.

## Write a Check

Write a check and make it payable to *Wabash College*. Drop off your gift in the Office of Annual Giving located in the Hays Alumni Center.

## **Credit Card**

Use your credit card to make a one time gift or to make your gift in multiple payments. Wabash accepts Visa, MasterCard, Discover, and American Express. Visit *www.wabash.edu/egift* to make your credit card gift online.

#### Indiana Tax Credit

If you file an Indiana state income tax return, the state will credit up to 50% of your gift to Wabash against your state income taxes. Individual filers receive a \$100 credit for the first \$200 contributed to Wabash, while joint filers receive a \$200 credit for the first \$400 contributed to the College.

## **Indiana License Plates**

Wabash College alumni, students, parents, faculty, staff, and friends with vehicles registered in the State of Indiana are eligible to receive a Wabash College license plate.

## Here's how it works:

- When requesting your Wabash plate from the BMV (online, by mail, or at the license branch), indicate that you want to renew your existing plate or get a new Wabash plate.
- The BMV will collect a \$25 gift to Wabash and a \$15 administrative fee for each plate purchased.

## Some important notes about this process:

- When requesting a Wabash plate from the BMV, be sure to indicate that you want the BMV to release your name and address for gift recognition purposes. By doing so, Wabash will issue an acknowledgement for your \$25 contribution and count you as an Annual Fund donor.
- The BMV will collect gifts of \$25 for each plate you purchase. If you regularly support Wabash with gifts greater than \$25, we would appreciate your continued generosity by making those gifts directly to Wabash by payroll deduction, mail, phone, or online at *www.wabash.edu/egift*

## **Matching Gifts**

If your spouse works for a company with a corporate matching gift program you might be able to double or triple the value of your gift to Wabash. Visit *www.wabash.edu/alumni/matching* to determine if you might be able to increase the value of your gift to Wabash.
