As a state approved licensure program, our programs meet state standards and credential requirements. Our Secondary Licensure Committee includes a local administrator among its members, and we have long-term relationships with members of the administration in the three local school districts where we regularly place students for practicum experiences, as well as several in neighboring counties where we have placed student teachers over the years. A core group of cooperating teachers in local districts have been involved in hosting our students for practicum courses and in student teaching, and we systematically collect data from them to assist us in designing instruction to meet current classroom needs. Introduction to ELL and special education as topics of development begin in our foundations courses with specific instructional methods for working with these populations being infused in the curricula of our middle school and high school methods courses. Guest speakers, field experiences in the middle and high school settings, and course assignments are examples of strategies we use. Most of the required field work in our programs include work in rural schools in our county; however, we also require candidates to take an urban education course that currently includes field work (20 hours) in the Memphis, TN Public School System in partnership with the Memphis Teacher Residency Program.

Our secondary students take foundations coursework in which they study philosophy and history of special education and ELL and become familiar with special education and ELL terminology, processes and methods. They then complete courses that involve field experiences that include classroom time and/or individual mentoring with special needs and ELL teachers in the area schools. Guest speakers (experts in ELL and Special needs) are utilized in methods courses to introduce students to best practices in both fields. We use our content methods courses to reinforce the special education and ELL work completed early in the students' programs. Each instructor is asked to implement into the course special education and ELL work in their content fields. Students' lesson planning and unit planning assignments in general methods and content-area methods courses include a requirement for adaptations for ELL and special education students. In student teaching, the students are involved in implementing IEP's with students in their placement classrooms. While they often do sit in on parts of the IEP team process, they are not treated as full members of the IEP team due to local district norms and procedures. .
