**Here's more still:** Six months after graduation, 95 percent of the members of the Wabash College Class of 2022 have settled into a first destination—employment, graduate school, or service. It marks the sixth consecutive year in which Wabash graduates have claimed their first destinations following graduation at rates among the highest in the nation. Over those six years, Wabash graduates have secured first destinations within six months at a rate of 98.4 percent, well above the 84.1 percent Career Outcomes Rate as reported by the National Association of Colleges and Employers, which is the best current measure for national comparison.

## **END OF YEAR REMINDER**

No doubt you've received communications from the college about including Wabash in your end-ofcalendar year giving. After the very rough economic times we've faced in 2022, if you're like me you're reading your IRA, Roth IRA, and/or 401-k or 403-b statements and saying "I'm seeing red."

One easy way to see **BLACK** still, financially, is to make a contribution to Wabash now. The good side of today's economy is that the college is now paying higher rates for charitable gift annuities. Below I've copied a table which the college sent to us recently. It is an example of how the interest rates have improved. So we're not QUITE there yet, but at age 70, a person making a \$25,000 gift to Wabash will receive an **immediate \$11,000+ tax deduction** as well as **an annual payout back of \$1,325**, more than half of it (\$877) tax free. That's the equivalent of earning seven percent on the money. I'm not the expert on these things. Classmates like KEVIN CLIFFORD or GARY REAMEY are, but the college's DAVID TROUTMAN is the guy to talk to if a return like this on a gift to the college makes some sense to you. #### A Good Thing Just Got Better

Gift annuities have always been a good idea. Now, when you fund one at the new, higher rates, something that has always been good, just got better! We have rates for *every age*, but, using a \$25,000 gift, here is an example of our rates and how they have increased:
