p.s. My boss wanted me to pass along some tax news. The CARES Act that passed last Spring included a tax law change for this year to encourage charitable giving. This year, people can deduct charitable contributions even if they use the Standard Deduction instead of itemizing deductions on Schedule A of the Form 1040. There are a couple caveats to this tax break though:

- 1) You have to make the contribution by December 31, 2020.
- 2) The maximum deduction under this provision is \$300. It's okay to give more, but if you want to deduct more, then you need to use Schedule A.
