p.s. A quick tax-tip from the former IRS employee:

A special provision of this year's COVID relief laws is a temporary expansion in the rules for charitable contribution tax deductions:

a) If you itemize your deductions, you are allowed to deduct contributions totaling up to 100% of your income! In normal years, the deduction is limited to half your income.

b) If you use the "standard deduction" instead of itemizing, you are allowed to deduct \$300 (if single) or \$600 (if married). The \$300 deduction was allowed last year also, but this year the larger deduction is an option for married taxpayers. If you're currently single, you can still get the larger deduction if you make your contribution now *and* then get married by the end of the year, so hurry! :={}}
