Wabash Community Updates

- Annual Fund 2013-2014 results. Over 5,200 alumni, parents, and friends made gifts to the Annual Fund for \$3,271,804. The FY14 Annual Fund dollar total was the second highest unrestricted dollar total in the College's history. Alumni participation was at 40.15% in FY14 versus 37.24% in FY13 and 35.06% in FY12. FY14 is the first year above 40% alumni participation since FY03.
- If you are curious how our class does with this, last fiscal year, 63 (37.5%) of our class contributed to the Annual Fund for a total of almost \$37,000. Our participation rate is slightly above the two graduating classes before us and the one right after us. However, the guys who were sophomores when we were seniors support the college at a higher rate than our class. They were a sharp group I remember, but we're better! WAF
