"I Will Not Follow You" : Sexual Labor and Bordeaux's Quartier Mériadeck

This manuscript challenges historical interpretations of sexual labor, working class identity, and notions of citizenship. Focusing on the place of prostitution and its regulation in 19th century France, my study of a small Bordeaux neighborhood shows that residents did not shun prostitutes. Tolerant and sympathetic to the women, residents relied on the grey economy generated by prostitution to sustained their livelihoods. The Mériadeck neighborhood developed as an oddity. It remained impoverished yet surrounded by affluent housing, productive manufacturing, and municipal buildings. Isolated, its residents developed a sense of unity derived almost entirely from their reliance on the shadow economy produced by sexual labor. In contrast, elected and appointed officials took a dim view of the prostitution that supported Mériadeck's residents. Officials increased restrictions, removing brothels from the area to improve morality while using "administrative detentions" to illegally imprison sex workers. In turn, brothel keepers and residents politicized to protect themselves; they argued that city ordinances were unreasonable or unfair and should be rescinded. Outsiders argued that administrative detentions were illegal. During the Bouche-Eon Affair, the procureur général asserted that prostitutes had a right to due process and *could not* be held without due process. Through an examination of news stories, petitions from sex workers and residents, police reports, and letters to officials, my manuscript demonstrates that Bordeaux's impoverished residents and sex workers understood French law and their rights. They politicized in order to protect their neighborhood and their livelihoods. This study also challenges historians' interpretations of the role of law in nineteenth century regulation in France. It argues that French prostitutes did not exist outside the law and could not be confined arbitrarily as a result of the work they did. Due to changes in French jurisprudence since 1789, the law remained on

the side of sex workers, requiring that they receive the same treatment as other French citizens.
