## PARKING

Parking is available in the Blackstock lot beginning at 9 a.m. for a \$5 fee per vehicle. Tailgating is only permitted in the Blackstock Stadium lot and the Peeler Art Center lot (RVs). Parking is on a first come, first served basis. All spaces will be used to park cars and may not be reserved. Once the lot has closed, no re-entry will be allowed. Additional parking is available on campus. Handicap parking is available in the Blackstock lot with seating available just behind the South end zone.

## RECREATIONAL VEHICLES

Due to space restrictions, RV's (and other similar large vehicles) are not allowed in the Blackstock lot, but may be parked in the Peeler lot. Please contact Public Safety for more information: [police@depauw.edu](mailto:police@depauw.edu) or 765-658-4261.

## TAILGATING POLICY

All tailgating activities must be contained within the permitted tailgating areas. Approved tailgating areas are the Blackstock Parking Lot and Peeler Art Center Lot for RV parking only.

Tailgating may begin no earlier than 9 a.m. on game day and is to be in grassy areas or directly behind a parked vehicle without blocking an available parking space or the flow of traffic in the lot.

As defined in this policy, tailgating may involve the consumption of alcohol in designated areas. DePauw University does not sanction the violation of federal, state, or local laws, including the consumption/possession of alcoholic beverages by underage persons. Individuals participating in tailgating activities at DePauw University are expected to conduct themselves in a respectful manner; including, following the directives of event staff and Public Safety officials.

Public consumption of alcoholic beverages on any other part of the campus or on public streets that run through or adjacent to campus is prohibited and subject to policy/law enforcement.

Drinking games (including but not limited to beer pong and other table games) and the use of devices intended to accelerate the consumption of alcohol (including but not limited to funnels or beer bong) are prohibited.

Persons acting in a disruptive, disrespectful or disorderly manner may be asked to leave the premises or be subject to arrest or citation.

Students may also be charged with a violation of the Student Code of Conduct.

Kegs and other common source containers are not allowed at any time.

Glass containers are prohibited. The use of plastic containers is encouraged for the consumption of all beverages.

The sale of alcoholic beverages is strictly prohibited.

Propane and charcoal grills are allowed when used solely for food preparation purposes. Burned coals and/or residue from cooking are not permitted to make contact with the paved surface of the parking lot or grassy areas. Open flame fires, including fire pits, are prohibited.

All groups and individuals participating in tailgating are responsible for the proper collection and disposal of their trash, as well as, other debris such as charcoal. Trash containers will be provided throughout tailgate areas.

## INSIDE THE STADIUM

DePauw University will adhere to the Division III Fan Code of Conduct Statement: "The NCAA, SCAC, and DePauw University promote good sportsmanship by student athletes, coaches and spectators. We request your cooperation by supporting the participants and officials in a positive manner. Profanity, racial or sexist comments or other intimidating actions directed at officials, student athletes, coaches or team representatives – as well as public intoxication, the consumption or possession of alcoholic beverages and tobacco products – are grounds for removal from the site of competition and other disciplinary actions."

The following may not be brought into the stadium:

- Alcohol
- Coolers
- Open beverage containers
- Pets (except service animals)
- Profane clothing, signs or symbols

Additionally, there is no re-entry.
