



Consumer Information – Immunizations 2026-27

We take the health of our students and our community seriously at Wabash. Our nationally-ranked Student Health Center believes that protecting our students and campus from preventable diseases is a priority to avoid disruptions to health and educational opportunities. Incoming students must complete their personal and family health history as well as other required forms, including mandatory immunization records, utilizing the online student health portal of our electronic medical records system (sign-in information provided to students separately). Please note: Indiana students' records will automatically be imported from CHIRP, the state database. Other students may need to reach their primary care provider, health department, or high school to obtain their records.

REQUIRED VACCINATIONS FOR ALL STUDENTS, 2026-2027 School Year

Documentation of the following:

- Polio series (IPV) – four doses, last dose on/after age four
- Measles, mumps, rubella (MMR) – two doses
 - Dose one must be given on or after the first birthday; the second dose at least 28 days later
 - Laboratory titers may be submitted as evidence of immunity
- Tetanus, diphtheria, acellular pertussis (Tdap) – In addition to completion of the primary series, one dose within at least 10 years of enrollment date
- Varicella (chicken pox) – two doses of vaccine, OR medical documentation of disease, OR titers indicating immunity from natural disease
- Meningococcal ACWY (also called MCV-4) – two doses; one dose is sufficient if given after age 16. There are newer vaccines which include ABCWY, five types of meningitis strains, for enhanced protection

RECOMMENDED VACCINATIONS

- Meningococcal B – two doses (this type of meningitis is the most prevalent, and has been associated with past college outbreaks, so we strongly recommend it); please note, there are two brands, and they are not interchangeable. Both doses should be of the same brand (Trumemba or Bexsero) to be valid
- Hepatitis A – two doses
- Hepatitis B—three doses
- Influenza – we make flu shots available on campus for all students and employees each fall, and recommend it for all community members
- Human papillomavirus (HPV) – two or three doses, depending on age at first administration
- SARS-CoV2 (COVID) – an updated COVID-19 vaccine approved by the Food and Drug Administration (FDA) or World Health Organization (WHO)

INTERNATIONAL STUDENTS

- Required to have an IGRA Tuberculosis (TB) blood test, which we will administer to you on campus. **Applies to students from high-incidence countries—p.18, ACHA Tuberculosis document.*
- If the required immunizations are not available to you in your home country, we will administer those to you during orientation. It is generally more cost-effective to obtain vaccines in your home country, when possible, but your student insurance will cover most of the cost once you are on campus.
